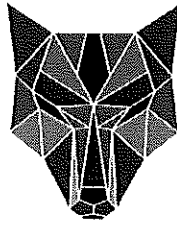

RE: COMPLISHIELD FINANCIAL GROUP (PTY) LTD

1. I act on behalf of Complishield Financial Group (Pty) Ltd, FSP No. 53590 ("**Complishield**").
2. On 22 August 2025 we addressed a letter to set out the position about the ongoing unlawful conduct of Mr. Wesley Harrington.
3. After having called into question my credentials (which cannot be questioned as my certificate of enrolment with the Legal Practice Council is available to all and sundry) as well as accusing CompliShield of criminal and other conduct, it turns out Mr Harrington is in fact the one who has no credentials and is acting criminally.
4. We attach a letter from the FSCA confirming Mr Harrington has no link to them, has acted on a frolic of his own and thus, as we have stated previously, has committed a fraud by misrepresenting his affiliation to the FSCA. This is a criminal offence which will be investigated both in the UK (Mr Harrington resides in London albeit he has refused to provide his exact address) and South Africa,
5. We attach our letter of 24 September 2025 sent to Mr Haslington – who conveniently no longer uses any designation affiliated to the FSCA.
6. Please be wary of any statements made by this individual or anyone associated to him., The FSCA itself has distanced themselves from him and by his own actions, so as he.
7. As stated above, Mr Harrington's credentials and authority have no basis or affiliation to any financial entity and it Mr Harrington who has committed offences.

Thank you for bringing the matter to our attention; it is appreciated.

The FSCA has considered the matter, and we have reached out to Mr Harrington (on 18 September 2025). Subsequently, Mr Harrington changed the name of "FSCAMonitor" to "financialdigitalmonitor" on TikTok and has removed the FSCA branding. For this reason, the FSCA is of the view that a public warning will not serve any purpose at this stage.

The Authority confirms that Mr. Wesley Harrington and Capital FX are not authorised financial services providers and were not mandated by the FSCA to provide services under the name "FSCAMonitor". It is the view of the FSCA that Mr Harrington did not provide financial services as defined to members of the public.

I trust that the above clarifies the matter.
